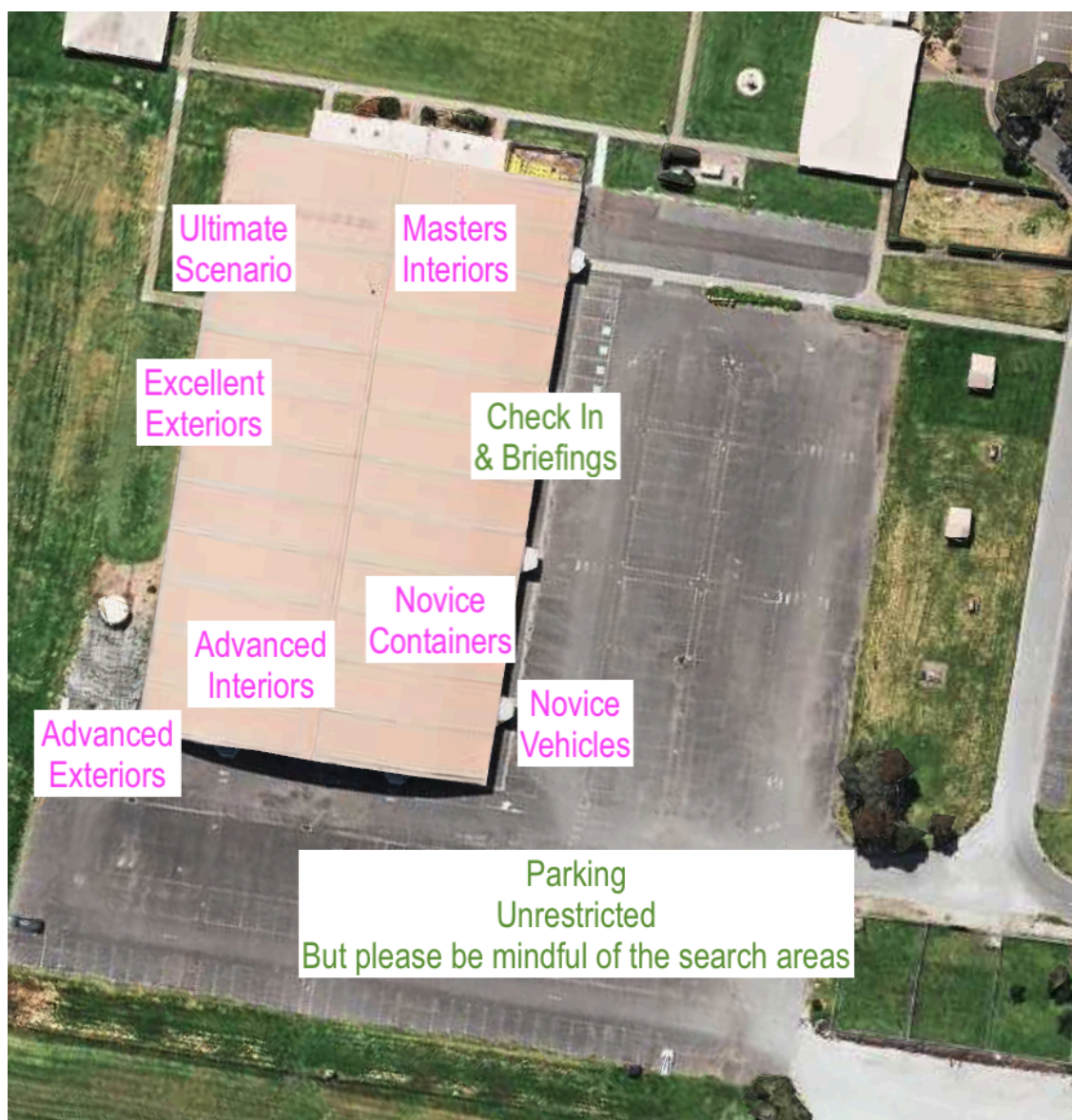

Judges will provide an overall general debrief and hand our encouragement awards at the end of judging. Thank you to all participants for attending and to the volunteers and the committee for all the work that has been in action to give our members a great day at the mock trial.

Catalogue: Mock Trial 29th March 2025

Notes for newbies:

Please find below the catalogue for each element of the mock trial.

At check in you will receive your catalogue number - but you also need to know your run order.

The catalogue number is what you tell the judges steward and judge on entry to your search.

The run order number is the order you go into a search and the number the marshal will be calling in the carpark - sometimes this is visible on a number board as well. Keep an eye on the run order numbers and be ready to approach and line up - usually 2 dogs ahead from the marshal. Make sure you give dogs and people space at the marshalling areas.
